The volumes are broken up into Immigrant and Non-Immigrant concepts. They layout all of the relevant visas and statuses available to clients in any scenario. Each chapter explains the practical uses of the visa/status, important questions to ask your client, relevant forms and timelines, and everything else you need to know and do.Besides compiling all of the relevant LAWS into one place, they also explain the practical meaning of the laws, PLUS something even more important: the authors capitalize on their vast experience and research to explain common pitfalls and practices in the area of business immigration. For instance, the law may say a client can obtain a certain type of visa if they meet requirements A, B, and C. However, this book will tell you that USCIS has adopted a policy of strict review for this certain type of visa, and therefore it is getting much more difficult to obtain, despite the law.My only complaint is the index. It is fairly good, but does not list topics in as much detail as I would prefer. I have seen and used much worse, but with so many pages and concepts, a more detailed index would be helpful.Frankly, it would be impossible for a new lawyer to practice responsible immigration law without this book. Even an experienced attorney would find these volumes invaluable to their practice.
